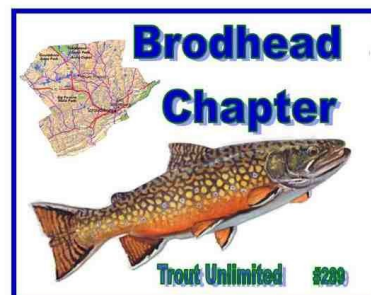

hile I'm writing this column, it's a balmy forty-five degrees outside and you could fish using nymphs. If you worked the bottom slowly and got your drift just right, into the holding position of a trout, you could be successful. Normally at this time of year, it is much colder and ice fishing would be the norm. The ice on any pond or lake is not thick enough to be safe to go out on, and the Tobyhanna Conservation Association has postponed their ice harvest until Saturday, February 18, to insure a safe thickness.

Brodhead Chapter has been busy teaching fly tying during January to about fifteen people under the leadership of our head instructor Scott Cesari and many dedicated volunteers. I hope the participants of the course will join us as members of our TU chapter and become active TU volunteers.

Scott will be instructing an exciting new class in Intermediate Fly Tying on February 25 and March 3. He will be building on the techniques taught in the basic class, and you will learn four new patterns, as well as how to prepare the materials with which to tie.

Hopefully, they will join with many of you and me at the February 8 General Membership Meeting to tie flies and learn techniques that we all develop as individuals as we tie flies. The Board has suggested that we donate flies tied at the February meeting to Project Healing Waters for the veterans and Casting for Recovery (breast cancer survivors). If we clean out our fly boxes, we can probably have enough flies to also donate to the Rivers Conservation School that PATU runs. They are interested in batches of three dozen of each pattern to provide one fly of each pattern to each student.

We need suggestions for candidates to send to the PATU Rivers Conservation School. They are already looking for applicants for this summer's group. If you know of a deserving youngster between the ages of fourteen and sixteen, please contact Bob Stevens with contact information. The early application period is now open, and they will be notified

by March 31. Candidates must fill out an application, write an essay, and provide information from a teacher in their school.

Don Baylor suggested that other chapters have trips to fish together. We recently formed a new Trips Committee, and after just one meeting, they developed our first chapter fly fishing venture! The committee has finalized our first chapter trip to fly fish the weekend of May 11-13 on New York's legendary Beaverkill-Willewemoc system, a.k.a. the BEA-MOC! You will find a flyer with all the details in this issue of *Streamside Asides*, as well as on the chapter's official website. (SEE PAGE 4.) You should already have received an e-mail with the flyer attached. There are a limited number of spaces available. The trip costs only \$100 per person, including 2-night's lodging, fishing location maps, a hatch chart and driving directions. Members would car pool to Horton, NY, sharing meal and gas/travel expenses. During the trip, we will also make a visit to the historic Catskill Fly Fishing Museum. If you are interested, please get your check for the full amount to Eric Baird, our Chapter Treasurer. It might also be a good idea if you called Eric (570-355-0165) to see if there are still available spots for this trip because we expect it to sell out very quickly!

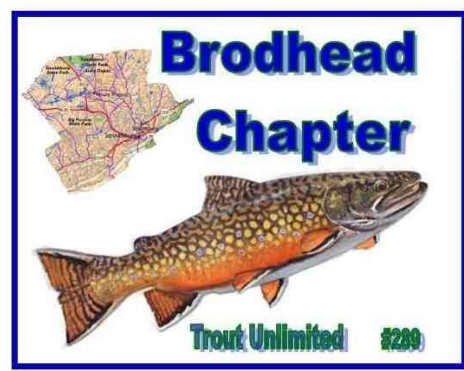

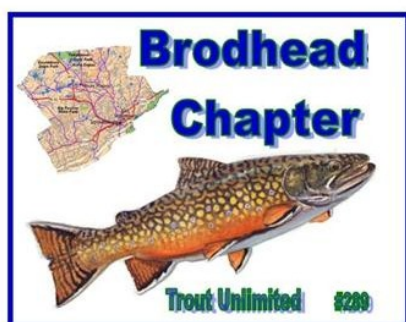

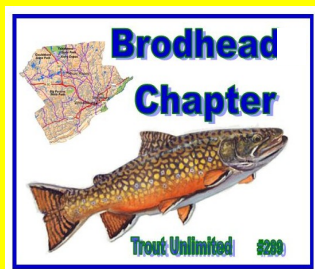

Wayne's Cold Water Kids 2012

Wayne Harpster has again generously offered young fly anglers a chance to fish the storied waters of the central PA's *Spruce Creek*. The event will be held at his family's Evergreen Farm on **Sunday April 29, 2012**. He hopes to build on last year's success. This year again he will open both sections for the event. His goal is to provide the youngsters with a quality FF experience based on the good fishing on Spruce creek that is enhanced by education and guiding from a variety knowledgeable fly fishing adults. The day will be topped off with a group meal at the covered bridge on the lower water. A special thanks to the PA TU Youth committee for their work in recruiting our young anglers. With the team of PSU Fly Fishing and TU joining the Harpster's, we plan to once again make the day successful for all involved.

General Information

A maximum of one adult per every two students is requested. There is a limit of 50 Students and 25 adults for the program. We suggest that they use their own equipment. PSU equipment to loan in an emergency. **All fishing is catch/release with no wading.** They must have their own flies and they must be fished barbless. In an effort to give the anglers more room we will be using two separate areas. You may have to drive back and forth to your assigned beat area. Please plan accordingly. There will be two educational presentations available to involve the youths until beat assignments are made and it is time to start fishing.: Joe Humphreys – Casting and Fishing demo AND Greg Hoover – Local FF entomology. **After Dinner Open Adult & Youth Fishing!! Depart site at Dark, but no later than 15min after sunset.**

This is a wonderful mentoring event that offers young anglers, ages 12-15, to fish the storied waters of Spruce Creek in central Pennsylvania. The event will be held at Wayne Harper's Evergreen Farm (off of route 45) on Sunday April 29, 2012. **If you have or know of any youth in your area that has fly fishing experience and would like the opportunity to fish Spruce Creek, we encourage you to contact TOM BATTISTA TODAY with the completed application and teacher recommendation!**

There is a registration fee of \$10 per child that each chapter will provide for its students. If you are interested in attending please complete the application on page 8 and return it with the educator's recommendation letter to Tom; he will send you detailed directions and an agenda. 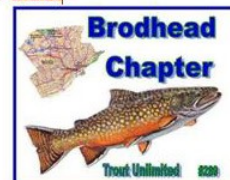

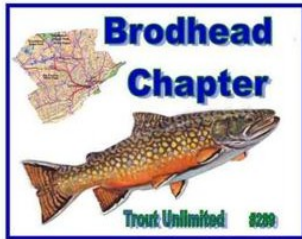

Fly of the Month

Scott Cesari

2006 PA State Fly Tying Champion

2006 Federation of Fly Fishers World Champion

I thought I'd start this year with my personal favorite fly, the *Bead Head Pheasant Tail Nymph*, tied on a curved shank hook. I find this to be a very productive pattern for our area, and I believe the curved shank gives it a more realistic, more alluring profile in the water. Make sure to tie a few of these for your box this coming season; you'll be happy you have them, I'm sure!

TYING STEPS

1. Load a bead onto the hook. Place the hook in the vice by the lower end of the bend. Try to keep the bend mostly exposed to facilitate the tying process.
2. Tie on the thread and make a thread base from behind the bead to partway around the bend of the hook. Return the thread to mid shank – this will be where you start to tie in the tail.
3. Maintaining proportions can be a little tricky with a curved shank hook, but with a little practice it's easy to master. Select and measure 3 or 4 pheasant tail fibers to create a tail that is equal to half the length of the shank (accounting for the curve of the hook.) It's easier to tie this in on top of the hook than at the bend (the vice jaws get in the way) and bind the fibers back along the shank of the hook until you reach the point where the tail should start. I try to have my tails angle down between 45 and 90 degrees, relative to the thorax of the fly.
4. Tie in a length of copper wire the same way, starting at mid-shank and binding the wire down to the shank to the point where the tail starts.
5. Now tie in a bunch of pheasant tail fibers at the bend where the tail/wire is attached, wrap the thread back toward the eye about 2/3 up the shank of the hook and wrap the fibers around the

hook in slightly overlapping turns to create the body. Again, the body should be about 2/3 the length of the fly (remember to account for the curve of the hook.)

6. Now counter-wrap the wire (e.g. – wrap in the opposite direction) to create a rib over the body. Counter-wrapping reinforces the fragile pheasant tail fibers and creates a more durable fly.
7. Tie in another bunch of pheasant tail fibers by the tips, butts facing the bend of the hook, at the front of the body. This slip will later be folded over to form a wing case.
8. Bring your thread to just behind the bead, run out a good bit of it and make a loop of thread around one of your fingers. Pull your bobbin up such that both legs of the loop are resting on the shank of the hook behind the bead, and secure both legs to the shank from the bead to the front of the body (like tying a jam knot when starting the thread on the hook.) Now clip one leg of the loop to create a tag end of thread. This will be used to reinforce the peacock herl thorax you'll make in the next step. (NOTE: This step is hard to describe, but you can see the technique on the video “beginner fly tying tips part 8 – the bead head pheasant tail nymph” on my website. Go to scottcesariflytying.com, click resources, click beginner fly tying class, and click on part 8 – the Bead Head Pheasant Tail Nymph.)
9. Tie in a few strands of peacock herl at the front of the body, twist the herl and the tag end of thread into a rope, and wrap a meaty thorax up to the bead. Tie off and clip away the excess.
10. Pull the pheasant tail fibers forward to form a wing case, tie off and trim. Whip finish behind the bead, add a drop of head cement, and your bead head pheasant tail nymph is ready to fish!

For those of you submitting a fly for the fly tying contest (which I hope you all will do), I will be looking at the following parts of the fly during the judging:

- ♦ Tail and thorax should be oriented 90 degrees to each other, or as close as possible to 90 degrees.
- ♦ Symmetry/equality of the counter-wrapped rib.
- ♦ Abdominal/thorax proportions of 2/3 to 1/3 respectively, accounting for the curvature of the hook.

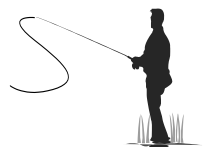
