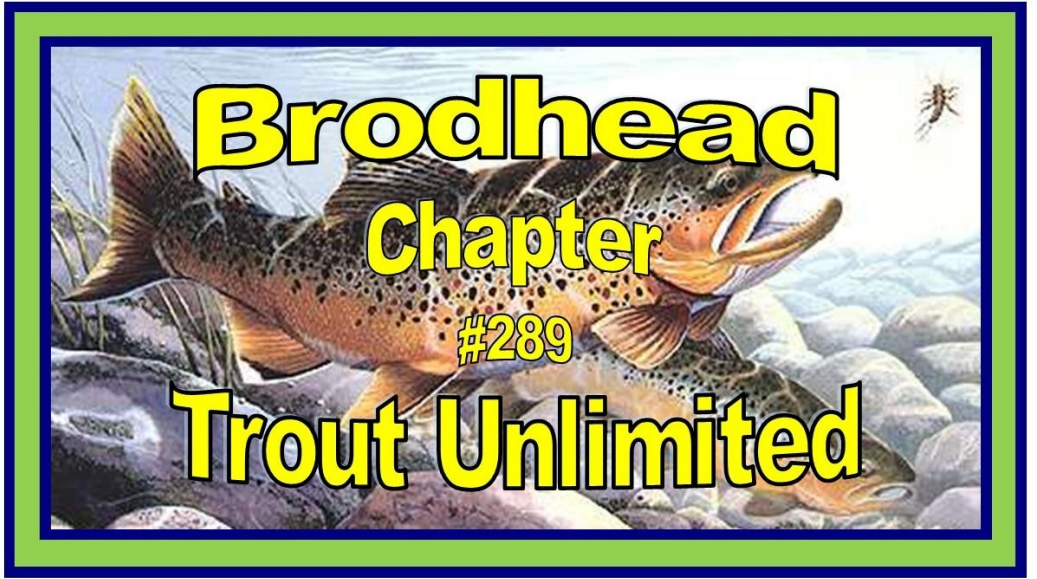

Dear Members and Friends:

It certainly appears fall is officially here as the days are cool, the nights are clear, and that desire to be back out on the stream is stronger than ever.

I start this column with an update on our conservation projects. Our permits are in place for the Pocono Creek project but, unfortunately, we couldn't get the boulders in the stream prior to the October 1 deadline. However, I'll be in contact with our contractor within the next day or two so expect to see a call for assistance as we help flag and move the rocks from their current resting place into storage areas along the banks of the Pocono. (We don't want to disturb or destroy any redds.) We plan to move the rocks into place next June when we once again can get back into the stream and do some work.

Permit-wise, we are also "okay" with the McMichaels Creek plans for work near the soccer fields along Route 33. Those water willows and small cobble stone bottoms can only provide so much cover. We hope to address this next summer, also.

Once again, I ask that you review our strategic plan. It can be found online on our web page at www.brodheadtu.org. This plan is important as it provides the Board and our membership with a

plan of action and a reference frame for the decisions we make. On page 9 of this newsletter, you'll see a brief synopsis of the activities in which we've engaged over the past year. You'll notice how easily the activities can be organized into categories. That's not an accident! Conservation and educational activities, at the youth and adult levels, are a prime focus of what we do as we take our mission into the community. This level of activity within our chapter is exceptional. For a group with approximately 190 "on the book" members, we accomplish quite a bit.

In fact, your efforts, our efforts, were recently recognized by the Pennsylvania Council of Trout Unlimited at their annual Fall Meeting in Shavers Creek, PA. On Saturday, October 3, the Council presented the Brodhead Chapter with two awards: Best Chapter Web Site and the Edward Urbas Outstanding Chapter Award. Yes, the BEST, in the STATE, in TWO categories. Fantastic! I assure you it was a pleasure to accept these awards for the Chapter, especially knowing how much you have worked and cared for all that we do. Your efforts involved fly-tying classes (2), fly-fishing workshops (3), Learn to Fish workshop at the DWGNRA, Knights Kids Fishing Derby, Monroe County Youth Field Day, Monroe County Conservation Camp instructors, Trout in the Classroom, Valor House and Project Healing Waters, Pocono Creek project planning, electrofishing and baseline data collection, McMichaels Creek project planning, legislative contacts and communications, working in cooperation with Pocono Heritage Land Trust, the Brodhead Watershed Association with signage and the Forever-green Nature Preserve and appearances with outreach at events such as the Friends of Cherry Valley program. We are staying true to our plan and the mission of Trout Unlimited and we should be proud of our efforts. Of course, with success comes the greater challenge of maintaining this level of effort and I challenge each of you, as we move forward, to continue your efforts in whatever way possible. If you've been looking to jump into the game from the sidelines, now would be a great time to do it.

Don't forget to check out our upcoming meeting schedule. I'll be providing some insight into the joys of trout fishing the Pocono area streams in the winter...yes, winter...at our upcoming October General Membership meeting on Oct. 14th. Following that, we have an important and new co-operative meeting in November as we join forces with the Western Pocono Chapter of TU in providing information on the Gas Pipelines in Pennsylvania. Head on over to the Clymer Library on November 19th at 6 PM for a very informative evening. We will close out our year with a new idea, "Pies and Flies." Join us for some pizza, some tying, and maybe even a wee bit of lying as we tell tales of our fishing adventures.

So, as the leaves begin to change colors, we turn our thoughts to ending the year in celebration of a job well done and get excited about what next year will bring. Thank you.

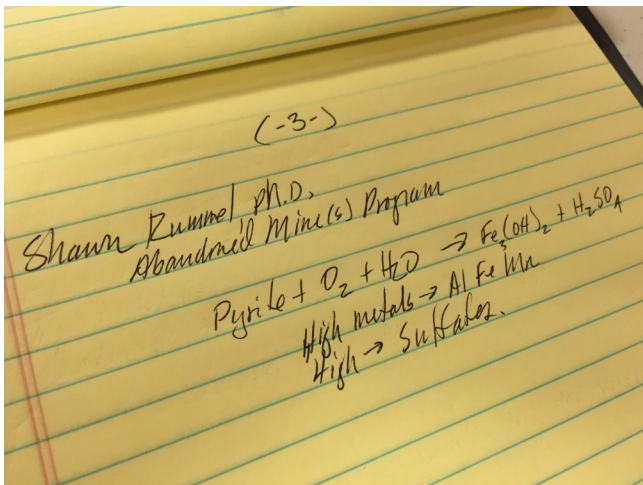

PA Council of Trout Unlimited Fall Meeting

While the highlight of the October 3 conference for the Brodhead Chapter was being recognized for our efforts, it also provided information on a variety of topics. PATU President started things off with a welcome and a thank you for the 48 PA chapters' efforts with the National Meeting in Scranton. Elections took place and BTU member Greg Malaska was elected PATU Vice-President. Congratulations Greg.

Dr. Shawn Rummel presented a segment on the Abandoned Mine Program (think Acid Mine Drainage) and Brook Trout habitat programs. For a brief period of time, Todd Burns thought he was back in college and enjoyed taking some new chemistry notes! Of particular interest here were the photos of the confluence of AMD steams and "fresh" streams. The fact that the colors represented the products of the chemical reactions settling or precipitating to the stream bottom caught the interest of the group. Red was the ferrous or iron compounds and the white represented aluminum salts. The low levels of aluminum needed to significantly impair a stream was startling.



Katy Dunlap worked with the assemblage on ways to more effectively advocate for our conservation issues. She emphasized the value of the TU brand and its credibility due to the scientific basis. The PA chapters registered 65,000 volunteer hours/year. She also discussed a request to contact our legislators concerning the Natural Gas Extraction Severance Tax (NGEST). We would be looking to fund an additional \$1,000,000 for the PFBC for enforcement in addition to the 1 million dollars for permit reviews.



PA Council of Trout Unlimited Fall Meeting (cont'd)

Katy encouraged all chapters to be sure that issues we sign onto are congruent with TU's mission. She encouraged legislative engagement, agency engagement, and grass-roots advocacy.

After the group broke for some conversations and the fly-casting contest (President Burns did NOT bring an award home here!) , Samantha Ferguson presented ideas on effective youth work and outreach. Of emphasis here was these people are the future of our group and we need to engage them early and in a positive fashion. She pointed out that Coldwater Heritage Partnership provides two types of grants: for planning and execution. She also pointed out that PATU had 37 chapters supporting 288 classrooms for Trout in the Classroom. Our PA chapters raised \$990,000 in funds and another \$1.24 million for service in kind. That's quite a haul!

A reminder was provided about the February 2016 Coldwater Conference in State College with an invitation to donate to support the attendance of college students to present their research and she reminded the chapters of the Embrace-a-Stream grants that are available. Brodhead TU was one of three PA chapters to receive such a grant in 2015.

Rivers Conservation Camp lost a major primary sponsor and the tuition is now \$400 per camper. The camp is looking for sponsors for the upcoming year. This is something we will be discussing at our next TU Board meeting. Finally, the Lackawanna Valley Chapter started a camp this summer and enrolled 24 students. While most were from the immediate area, one was from Sweden! They are looking to continue with the camp in the future.

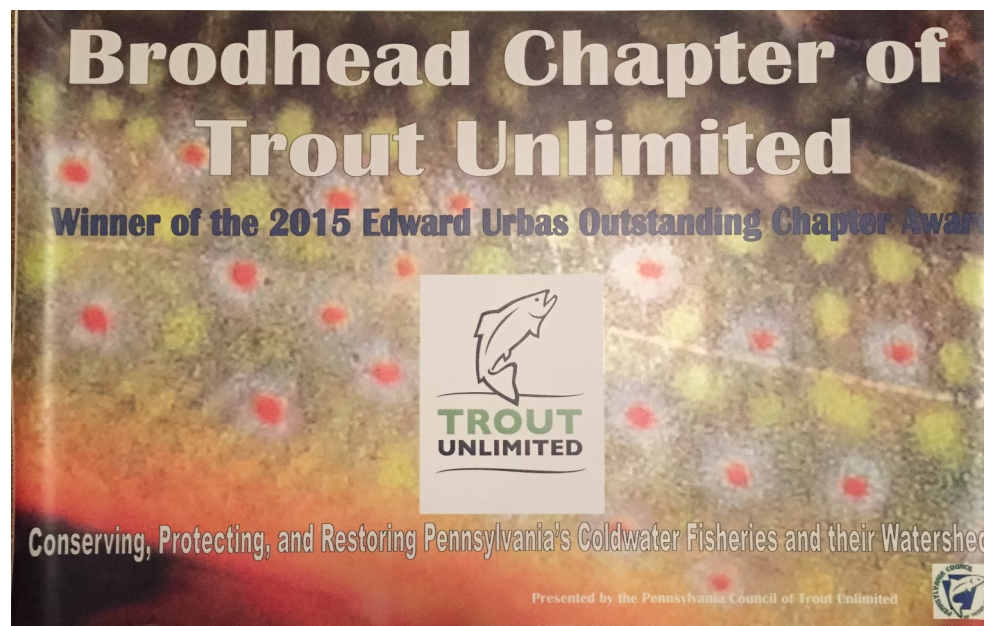
All in all, the 2015 Fall PATU meeting was informative, enjoyable and worthwhile to those in attendance.

Pennsylvania's Gas Pipelines Avoiding & Minimizing Impacts on Streams

The Brodhead and Western Pocono Chapters of TROUT UNLIMITED (TU) are proud to announce a unique, jointly-sponsored, program about how TU is working to make sure that impacts from major interstate pipelines on the commonwealth's coldwater streams are avoided or minimized. This innovative program will be offered FREE to the public on Thursday, November 19, 2015 at the Clymer Library, 115 Firehouse Road, Pocono Pines, PA from 6:00-8:00pm. The evening features three members of Trout Unlimited's national staff.

According to the Department of Environmental Protection, Pennsylvania is expected to see up to 27,000 miles of new pipelines by 2030. Katy Dunlap, TU's eastern water project director, will describe Pennsylvania's landscape of proposed major pipelines, potential impacts to water resources and fisheries, and the regulatory framework for major natural gas pipelines. Jake Lemon, TU's eastern shale gas monitoring coordinator, will explain how citizens can play a practical role in watching over coldwater streams by conducting pipeline monitoring before, during and after construction. Paula Piatt, TU's eastern sportsmen organizer, will describe how TU is working to achieve protective water quality and fisheries designations to ensure that as pipelines are permitted, appropriate conditions are placed on development.

This is a major, cooperative joint venture developed by TU for the benefit of sportsmen and women in the Poconos, as well as surrounding areas. This program represents TROUT UNLIMITED at its best working together to create protection and awareness of conservation of Pocono trout and their vital fresh water habitat.
