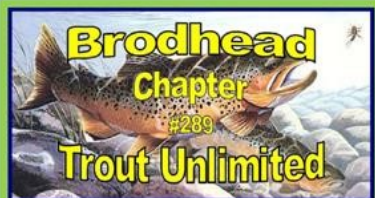

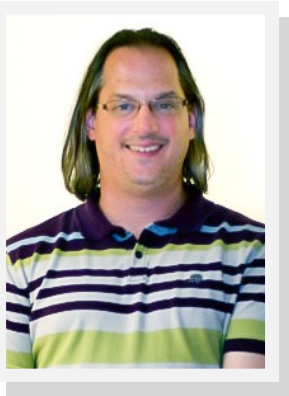

Greetings Members and Friends,

As I sit here writing this, I can hear the rain melting away at the snow and ice outside bringing on thoughts of spring, but even as our minds drifts to visions of tight lines and full nets we can't forget about the work we have in front of us. On the advocacy front several pressing campaigns are underway. The efforts to gut the Clean Water Rule are up for comment until April 15, 2019. I highly recommend you take a minute to add your name to the [action alert](#). By the time you read this people are already making final arrangements to travel to Washington DC with the Coalition for the Delaware River Watershed to talk to our legislators about issues impacting our cold water fisheries on March 12. At the state level, the current budget proposed to transfer 76 million dollars from the Growing Greener Environmental Stewardship Fund and the Keystone Fund to make up for budget shortfalls, I urge you contact Governor Wolf and your state legislatures to make your opinion known. On a local level, if you have not signed the [Our Pocono Waters](#) petition, I urge you to do so.

On a more jovial note, tickets are on sale for our annual banquet on March 29, 2019. Don't wait, we nearly sold out last year. You can order your tickets through the mail or we will be selling them at all upcoming chapter events leading up to the banquet. #### USFWS' Michael Horne receives national Land Legacy Award

Michael Horne, Project Leader for the Lenape National Wildlife Refuge Complex — encompassing refuge lands in New Jersey, New York, and Pennsylvania — has received the national Land Legacy Award from the U.S. Fish and Wildlife Service Division of Realty for significant contributions to land protection, amounting to 2,422 acres and counting.

"Mike has a way of making land-protection projects happen," said Mark Maghini, Chief of Realty for the Northeast Region. "He's got a great network of partners, and he is able to leverage those partnerships to help us to stretch our land-protection dollars further," he said. In the past two years, 95 percent of the land acquisitions in Horne's jurisdiction have been the result of donations or bargain sales.

"He really has a vision for the possibilities that lands represent," Maghini said, noting Horne's forward-thinking acquisition of a former golf course adjacent to Cherry Valley National Wildlife Refuge.

Within just a few months of the Cherry Valley deal closing, Horne had spearheaded initiatives to restore natural flow to a creek on the property, transform the fairways into habitat by planting warm-season grass species, and repurpose the golf cart paths to create ADA-accessible trails.

## News Notes, Advocacy Opportunities, and Items of Interest:

### Upcoming Grant Activities

The Board is awaiting word on our Forever Wild Mini-Grant from PA TU. If we are successful, we would be applying those funds to complete signage on the Learn Preserve in Tannersville. If you haven't checked out the creek and trail yet, get ready to go...it's (almost) Spring!

### Legislative News:

- **Proposed Repeal of the Clean Water Rule:** The Army Corps of Engineers (Corps) and the Environmental Protection Agency (EPA) are proposing to significantly narrow the scope of protections for our nation's waters. The proposal would replace a positive, TU-supported 2015 rule (the Clean Water Rule) designed to clarify the scope of Clean Water Act protections, which includes protections for headwaters, intermittent and ephemeral streams, and wetlands. The **new proposal (Replacement Rule) would substantially weaken the Clean Water Act**, one of the Nation's most effective natural resource laws. Go [HERE](#) to learn more and make your comment heard. Your comments are important and the deadline is April 15, 2019.
- **Land And Wildlife Conservation Fund:** After five months of lapsed funding, the Land and Wildlife Conservation Fund was approved by the U.S. House and U.S. Senate as part of a larger Natural Resources Management Act (S.47). This program is funded through off-shore oil drilling fees. More information can be found by following this [LWCF link](#).
- **PA House and Senate Environmental Resources and Energy Committees:** Proposed environmental and/or energy related legislation in Pennsylvania will pass through these committees. It is important to be aware of what steps are being taken regarding our natural resource utilization and management. Follow these links and, we suggest, bookmark them and review frequently!

- **Delaware River Restoration and Conservation Awarded \$6 Million for 2019:** On February 15th, the Delaware River Basin Restoration Program (DRBRP) received \$6 million in funding as part of the fiscal year 2019 Interior Appropriations bill approved by Congress and signed by the President, a \$1 million increase from last year. The DRBRP will provide much-needed technical assistance and grant funds to address the Delaware River Basin's environmental challenges. View full press release [here](#).

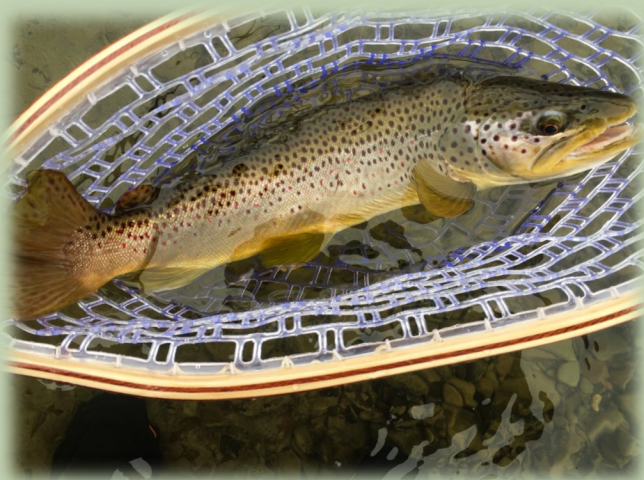


## ***BTU Activities...Fishing Report***

Ahh, here we are, just a few short weeks away from the Regional Opening of trout season on Saturday, March 30, 2019 (southeastern counties only) and, two weeks after that, the Statewide Opener (our opener) on April 13, 2019.

**Brodhead Creek, McMichaels Creek, and Pocono Creek** produced some nice fish in February—after the ice left us. Waters finally receded and we're hopeful they will be in great shape for the opener. Remember, these stocked streams are closed to fishing\* until 8 AM on Saturday, April 13, 2019. Below are a few catch and release photos to tide you over until then!

\*The Delayed Harvest-Keystone Select Water on McMichaels Creek at Hickory Valley Park and by Glenbrook Golf Course is fishable year-round. Please refer to your fishing regulations booklet or the [on-line version](#). Also, the Delayed Harvest—Artificial Lures Only section of Tobyhanna Creek below Still Swamp Run is also open to fishing year-round. Be advised no trout may be harvested in these waters until June 15th, 2019.

## Recent Freshwater Salinity Work

An article authored by Tim Vernimmen appeared in Scientific American on December 6, 2018 and it outlined the general processes by which our freshwater streams and rivers are becoming saltier. A January 2018 study referenced in the article indicated up to 30% of our streams and rivers have “gotten saltier” in the past three decades. In some areas of the country, such as the upper mid-west, where salinity is naturally high, the increase is due to mining activities that disturb bedrock and release the captured saline waters. In our area of the Northeast, urbanization with roads leads to an increase and the Mid-west and Southwest see large increases in salinity due to agricultural practices. So what effect(s) can such an increase in salinity produce – especially when they occur in freshwater streams?

Mayfly larvae, a dietary staple of the trout in our streams, are susceptible to increases in salinity. John Jackson, from Stroud Water Research Center in Avondale, Pennsylvania, examined these effects on four different mayfly species. He found that once salt concentrations reach about 1/10 that of seawater, three of the four mayfly species’ larvae die. (Take away the food, and the trout disappear also.) William Hintz, Darrin Fresh Water Institute in New York, found that development in young rainbow trout is slowed by high salinity levels, thus impacting their long-term survival and their ability to reproduce. Finally, Hintz also found that water fleas, a source of food for bait fish and a key component in the aquatic food web, die when exposed to high, but realistic, salinity levels.

The study into the effects of increasing salinity in streams, groundwater and lakes is a growing and evolving area of interest. Too much salt can have a negative impact upon freshwater ecosystems (trout and trout food) and for those areas that offer access to such ecosystems it will be important to gather data to determine to what extent salinity is increasing.
