It has been a sad couple of days for our cold water resources with the EPA decision to reverse the Clean Water Act removing protections for headwater streams and isolated wetlands. I highly recommend contacting both your federal and state legislators and demanding a statutory remedy to this to this assault on the resource we all hold so dear.

Our next meeting will not be until Wednesday February 12, 2020 at the Kettle Creek Environmental Education Center with our annual Fly Tying Round Robin. So please stop by and tie some flies. The Brodhead Fly Tiers will be meeting at the Eastern Monroe Public Library on Monday February 17, 2020.

News Notes, Advocacy Opportunities,

BTU Strategic Plan: The Strategic Plan for the Brodhead Chapter is finalized and was emailed to you for your review. It is available on our web page at Brodheadtu.org. The plan will be posted through Feburary 2020 after which we will discuss it and vote on it's acceptance at our March 2020 General Membership Meeting. This five-year plan will help guide our activities as we move ahead and we look forward to your participation.

PA Legislative News:

We encourage you to stay up-to-date on current legislation in the PA House and Senate. Bills can come up for a vote quickly and your voice can make a difference. For updates on what is happening, we encourage you to visit:

This resource is searchable so you can simply type in your topic or Bill # and find some information. Also, we sometimes send Local Action Alert emails to our membership when an important legislative vote is imminent. The most recent was for SB 790. Did you contact your legislator?

<u>Federal:</u> As we stated in the January newsletter. regulatory "roll-backs" are still occurring with the latest being the passage of the update to the Clean Water Rule. The U.S. Environmental Protection Agency (EPA) and Army Corps of Engineers (Corps) announced a final "Waters of the U.S. Rule" on Jan. 24, 2020. This rule replaces the 2015 Rule, which clarified the extent of jurisdictions for clean water act protections. <u>This new 2020 rule (Navigable Waters Protection Rule) not only reverses the clarifications made in the 2015 rule, but further reverses protections that have been in place dating back to the 1970s. BTU Action/Activities in 2019

For a relatively small chapter, Brodhead TU is incredibly active and involved. Below is a brief description and then a listing of the activities in which our leadership, membership, and friends engaged in calendar year 2019, **excluding** regular Board and General Membership meetings. From an hours volunteered standpoint, our biggest foci were: Educational activities, conservation activities (stream projects and cleanups) and

Stream Habitat Improvement Projects: BTU worked on Cherry Creek in the Cherry Valley National Wildlife Refuge to create and improve trout habitat along some 2000' of stream. Our partners in this effort were the Friends of Cherry Valley, Pocono Heritage Land Trust and the US Fish and Wildlife Service. Special thanks to neighbor and friend Royce Fetherman for supplying trees for our brush deflectors. Additionally, the chapter partnered with the Brodhead Creek Regional Authority (BCRA) to improve habitat in Pocono Creek near the Rte. 715/611 intersection. This Phase IV section was the last portion of the stream planned for improvements. Another vital partner in these efforts was Aquatic Resources Consulting, who performed the pre – and post-improvement electroshocking data collection.

Streamside Clean-up: BTU members and friends once again cleaned up the banks of Pocono Creek and Bisbing Run in Tannersville. A pick-up truck full of debris, trash and other materials was picked up from the streams, their banks, and the surrounding properties. Many thanks to all our members and those friends from the Pocono Heritage Land Trust and Brodhead Watershed Association who helped in this effort. Wouldn't it be great if we didn't need to do this?

Educational Outreach: BTU conducted multiple fly-fishing workshops (4) and a multi-session flyting course. Chapter members also tabled at various community days (5) and other such events (Earth Day) in order to provide information on our cold-water resources and their importance. The chapter sponsored campers at the Monroe County Conservation District Youth Camp and at the Rivers Conservation Camp. Additionally, the chapter sponsored a program to build waste fishing line recepticles to be placed along streams in public access areas throughout the county. Our Trout In The Classroom efforts experienced the addition of Stroudsburg High School and we assisted with their Release Day at Cherry Valley National Wildlife Refuge.






