



## Brodhead Chapter Tables at Quiet Valley Harvest Festival

## BTU Volunteers Assist with Post-Improvement Electrofishing Survey on Cherry Creek




On Thursday, September 16, volunteers from the Brodhead Chapter assisted Aquatic Resources Consulting in conducting an electrofishing survey on the upper and lower sections of Cherry Creek within the headquarters tract of the Cherry Valley National Wildlife Refuge. The survey's purpose was to collect data in order to compare it to similar data obtained prior to the habitat improvement. Having both pre and post work data available, a determination can be made as to the benefit of the improvements.

The volunteers conducted two passes through each section and collected the trout for measurement of length and weight. After these data were recorded, the trout were released back into the creek. The data will be

fed into the appropriate equations and the results will be reported. Preliminary and anecdotal information shows little change in the downstream section but definite improvement in the upstream area. Once the final report is compiled, we'll be sure to publish the results. Stay tuned and many thanks to those who came out to help.





## Committee Updates

Brodhead TU has several active committees focused upon meeting the needs identified in our Strategic Plan. If you would like to volunteer to serve on one of these committees, please contact a Board member at your convenience. Below are brief descriptions of what each committee does and some actions they have recently undertaken.

**Advocacy**— Advocacy alerts members of upcoming policy and/or legislative changes that can impact the cold-water resources in the Poconos, the state, and the nation. Legislation that heads through the House and Senate in Harrisburg has the potential to directly or indirectly affect the coldwater fisheries throughout the state. See pages 8 and 9 for more details. H.B. 1842 has been added.

**Diversity Initiative**— Focuses upon strengthening the chapter by providing information and activities that will attract and retain members across the spectrum found within our communities. In line with TU National's Harassment Policy, the Chapter continues advertising and providing a link for reporting of harassing activities. This is a vital step in creating and maintaining an atmosphere that welcomes all persons interested in BTU's activities.

**Fundraising**— Through the on-line auction and submitted donations, the chapter raised \$4165 in new funds for the McMichaels/Pomeroy project in addition to the \$12,000 already in-hand. BTU submitted its application for a TU Embrace-A-Stream grant and we believe we should receive at least \$7,000. BTU also applied for a PFBC Cooperative Habitat Improvement Project (CHIP) grant with the PFBC and they notified us we will receive \$5,600. Our current total raised for materials is \$28,765. Projected materials and labor costs for this phase of the project are \$43,965. The committee will continue to pursue grant opportunities and other fundraising activities.

**Conservation**— Pomeroy work plans await final funding and coordination with PFBC. The committee also is soliciting input for additional work sites in the future. Recent flooding has had a significant, negative impact on some of our past projects and it may be time to re-address those needs. Stay tuned as the ideas are coming quickly!

**Tree Planting**— Emphasis on projects along Middle Creek in Polk Township and Cherry Creek at the Josie Porter Farm continue. Committee members toured the Middle Creek site with representations from the Polk Township Recreation Committee with a follow-up meeting on 10/23. They are planning a similar meeting on 10/24 at the Josie Porter tract. Once plans are finalized, appropriate types of trees will be ordered. At that point, a call will go out for volunteers to get those trees in the ground!

## News Notes, Advocacy Opportunities, and Items of Interest

### **PA Legislative News:**

The 2021 Legislative Session is back and running and committees in both the House and Senate are active. Bills of note:

1. [H.B. 1842](#). The House Environmental Resources and Energy Committee voted this out of committee. The bill, a companion bill to S.B. 545 below, utilizes some of 545's language. Again, it would allow non-professional judgments on attempted clean-ups and seeks to tie pollution to only specific, numerical thresholds.
2. [H.B. 1144](#). This bill has passed the House and is now in Environmental Resources and Energy in the Senate. This bill would legalize the dumping of oil and gas drilling wastewater on gravel and paved roads. PSU has conducted two studies indicating such actions have detrimental effects on the environment.
3. [S.B. 545](#). Now back in the Appropriations Committee, this re-write of last session's failed S.B. 619, would allow polluters to determine if they should or should not report a spill. Existing law requires spills to be reported to DEP where trained professionals determine the severity and ecological impact of the spill. Seeks to tie pollution to only specific, numerical thresholds.
4. [S.B. 832](#). Would establish a new fund dedicated to water quality, specifically focused on mitigating "non-point" sources of pollution, such as agricultural runoff and acid mine drainage, that are diffuse throughout the landscape. Funding in the amount of \$250 million dollars would be appropriated from federal dollars allocated by the American Rescue Plan Act of 2021.

After reviewing these bills and their summaries, please contact your senator and relay your thoughts.

Be advised there are usually multiple bills being considered that could ultimately affect the quality of our streams and groundwater.

# Fall Fishing Outlook



## Spawning, Flooding and Post-Storm Fishing

Fall is upon us, the nights are cooler and the leaves are turning shades of orange, red and yellow. What a great time to be on the water! But as we head into this new season, please keep a few items in mind; for your safety and the trout's.

1. It is spawning season for our native brook and wild brown trout. They build their redds in the tail-out flats of pools and runs from now through early December. Please be careful with your wading (look for those "clean" oval patterns on the bottom) and don't target fish that are near the redds.
2. Recent floods have had some major impacts on our waterways (see pages ). Be careful with your wading as new cuts, runs, and strainers have been created. What once was there, may not be now!
3. As the waters cool and the fishing heats up, don't forget those streamers in your fly box. Honestly, they work! And as the fall feed provides calories for trout to sustain them through the leaner winter months, they look for as many calories as possible. A weighted zonker or bugger run deep can produce some really nice fish.
4. Remember to keep 'em wet and release quickly.

Located within the Pocono Heritage Land Trust's recently established Pomeroy Preserve, adjacent to Hickory Valley Park, this stream section is part of the PA Fish & Boat Commission's Keystone Select Trophy Trout/Delayed Harvest program and offers public access and year-round fishing opportunities.

As beautiful as this section of creek is, in-stream habitat is limited, and will benefit greatly from Brodhead TU's science-based habitat restoration work. The Chapter's past projects on the Brodhead Creek, Cherry Creek, McMichael's Creek and Pocono Creek resulted in improvements in the ability of trout to reproduce and flourish. This restoration project will do the same.




