#### General Membership Meeting Wednesday, September 14, 2022 at 7:00 PM Kettle Creek Environmental Education Center

 MCCD Presents an update on the Sand Spring Run Streambank Restoration Project.

Lori Kerrigan, is currently the Head Resource Conservationist and supervisor of the permitting/technical section at Monroe County Conservation District. She holds a



Bachelor of Science in Sustainable Watershed Management and an Associates in Forest Technology. Recently, Lori has facilitated the development of a partnership with the PA Game Commission and DEP. Through this partnership, MCCD obtained a two-part Growing Greener Grant, to improve water quality, restore the natural stream functions, minimize bank erosion and restore habitat in a headwater reach of Sand Spring Run in the Upper Pocono watershed. The project came about to address an historic stone box culvert failure, below the 75-foot high impoundment that supported the Wilkes Barre and Eastern (WB&E) Railroad crossing.

When completed, the "Sand Spring Run Streambank Restoration Project" will provide a significant reduction in sediment loading to the Pocono and Brodhead Creek Watersheds, restore riparian buffer and enhance instream and riparian habitats.

# Material Delivery Starts for Pomeroy-McMichaels Habitat Improvement Work

Late August saw the delivery of over 200 logs needed for Phase I of the Brodhead TU chapter's habitat improvement work on McMichaels Creek. Three tri-axle truck loads, some 68 tons of hardwood, were delivered to the site on the Pomeroy-McMichaels Nature Preserve. BTU members Tim Fretz, Jim Connor, Don Miller and Todd Burns helped with site preparation, flagging, and clearing overhead tree limbs so the deliveries could occur. Thanks to Matt Schultz, Pocono Heritage Land Trust, for his assistance in identifying storage areas and in clearing brush.

The logs will be used to frame most of the devices proposed for the in-stream work. These include 17 log-framed stone deflectors and one log-framed, stone-throated cross vane. Additionally, many boulders will be placed in the main channel. Collectively, these devices will narrow and deepen the channel, increase flow velocity, and provide much needed shelter and feeding lanes for the wild and stocked trout. These changes should help moderate stream temperatures, improve habitat for macro-invertebrates, and provide safe havens for the fish. A start date for the work is still being determined.





#### **Sand Spring Run Rehabilitation Project**

For years the old railroad embankment along Sand Spring Run, upstream of the confluence with Wolf Swamp Run and Dry Sawmill Run, eroded during high water events. The affected portion of the stream bank was extremely large and this erosion resulted in muddled water downstream with the deposition of sediment throughout the Pocono Creek watershed.

The Monroe County Conservation District acquired Growing Greener funds and partnered with the PA Game Commission (the site is on State Game Lands) and DEP to develop a plan to remediate the damaged area. The comparative photos shown below reveal the progress to date. On the left is an initial photo taken prior to any work being done. The photo on the right shows the area as of August 22, 2022. The slope angle has decreased, anti-erosion barrier put in place and vegetation is recovering along the stream bank.





Whereas the work area is in the headwaters of Pocono Creek, reduction of sediments and restoring the riparian buffer will be exceptionally beneficial for the downstream areas. Excessive sedimentation negatively impacts the growth and reproduction of macro-invertebrates. Reducing this sediment load should result in improved populations of the insects that help feed the trout and other organisms.

# Statement from Pocono Township September 6, 2022



#### FOR IMMEDIATE RELEASE (MORE INFORMATION TO FOLLOW)

The Pocono Township Board of Commissioners took action at their regularly scheduled meeting this evening (9/6/22) to do the following:

- I) The Board of Commissioners declared the Pocono Township Zoning Ordinance "defective," per the PA Municipalities Planning Code, as it pertains to uses including "warehouses," "logistics centers" and "fulfillment centers." Several specific ordinance provisions were mentioned as to why the Ordinance is defective and inadequate to address new uses and definitions. This effectively gives the Township options on proposed future land development projects pertaining to these uses while the Township addresses these deficiencies through a curative amendment to the Township Zoning Ordinance. The Township now has 180 days to develop zoning language that better addresses and provides for these proposed uses. Please note that this does not "stop" existing land development plans that have been or are being actively reviewed. However, the Board of Commissioners is focused on addressing the increase in these large-scale land development plans and the concerns of our community. Please stay tuned for more information.
- 2) The Board formally moved to explore the purchase of the Pocono Elementary Center property with Pocono Mountain School District. Pocono Township indicated interest several years ago in the purchase of the facility for a proposed new municipal complex and community center. At that time it was stated that the School District was not interested in the sale of the property. In the meantime, the Township has undergone, and continues to undergo, architectural feasibility studies to assess options for rehabbing the Township's municipal complex a facility that was last renovated in 1989 for today's needs.

The Township recently became aware that the School District is considering the sale of PEC and is entertaining offers on the property. Pocono Township will now contact Pocono Mountain School District leadership and work to prepare an offer on the property for the purpose of establishing a new municipal complex, developing a community center and preserving a community asset. We thank the members of the PMSD School Board who were in attendance at the Township meeting and we look forward to engaging in a mutually-beneficial conversation with the District.

3) The Board moved to require the Pocono Township zoning officer take an active role in all land development applications submitted to the Township to ensure full compliance with all existing Township zoning requirements.

#### **Local Updates:**

- The <u>Monroe County Planning Commission</u> will be holding a public meeting to show the results of **Return on Investment** report on September 13, 2022.
- <u>Coolbaugh Townsip</u> Zoning (Big-box warehouse proposal) Tobyhanna Conservation Assoc., PennFuture, PHLT, a homeowner's association and one immediate neighbor were allowed to comment/testify at a public zoning hearing board meeting. No final resolution yet—another hearing will be scheduled.
- Meeting held Monday, August 29, 2022 in <u>Pocono Township</u> regarding proposed Core5 warehouse.
- Our Pocono Waters released an Economic Impact Report on the value of HQ and EV waterways.

#### BTU Position Statement on Distribution Centers/Warehouse Construction

Currently, preliminary plans or discussions are being carried out concerning the construction of massive distribution centers throughout the greater Pocono region. Projects are being considered and are in various stages of planning, review, comment and hearings. Several of these are in the Pocono Creek corridor in Pocono Township and also in Coolbaugh Township along Tobyhanna Creek.

Brodhead Trout Unlimited understands warehouse development will occur, and it believes that such development must be done in areas that do not impact the absorbtion, retention, filtration and free movement of rain water and other precipitation near cold-water resources. It should not reduce the size or quality of wetlands, provide damaging thermal and/or saline stress due to runoff, or cause increased siltation in our streams. The cold, clean trout waters for which the Poconos is known should not be degraded and BTU is willing to work with residents and local governments to achieve this goal.

### Spin Fishing for Wild Trout

#### General Membership Meeting on TUESDAY, October 11, 2022. Location TBD.

Would you like to learn the secrets of how to catch more trout than most anglers think is possible? If so, you won't want to miss Frank Nale's PowerPoint program on fishing spinners for wild trout. Frank is from Blair County and casts his homemade lures in large streams such as the Little Juniata River, Penns Creek, and Spring Creek in Centre County, as well as numerous small streams, both limestone and freestone. This fast-paced program will cover proper spin fishing tackle, correct technique and stream selection,





Yes, we've had our first appreciable rainfall in over a month and our streams and ponds got a bit of a drink. The weather forecast for the next two weeks shows some more showers and cooler temperatures. If those two predictions are correct, we just might get some trout fishing done! Expect water conditions to remain low, even with some rain, but the cooler daytime and evening temperatures will help activate the trout.

Terrestrial patterns will remain a good bet as ants, hoppers, and inchworms will be moving about. Don't be surprised if you come across some Isonychia (Slate Drake) duns or Blue-winged Olives. This late in the year, they may be a bit smaller than usual. Also, don't forget the October Caddis (Okay, it's September, but you get the idea.) Small stonefly nymphs are always a good bet in the Poconos and of course you should break out your trusty streamer box.

Under these low water conditions, don't be afraid to go with small tippet or leader sizes for dries and nymphs. Unless you hit it the day after a rain or are fishing streamers, the clear stream waters may require that 6x or (gasp) that 7x that's been in the bottom of your vest pocket. Be gentle.

Whatever the case, try to get out and enjoy some late summer and early fall fishing this month. With the leaves predicted to turn early, a day on the stream can be a beautiful experience.


