

## BTU Presents Legendary PA Trout Angler, Frank Nale, October 11, 2022 at 7:00 PM Roseto Rod & Gun Club

Would you like to learn the secrets of how to catch more trout than most anglers think is possible? If so, you won't want to miss Frank Nale's PowerPoint program on fishing spinners for wild trout. Frank is from Blair County and casts his homemade lures in large streams such as the Little Juniata River, Penns Creek, and Spring Creek in Centre County, as well as numerous small

streams, both limestone and freestone. This fast-paced program will cover proper spin fishing tackle, correct technique, stream selection, and the other things he enjoys while streamside besides catching trout.

Frank, a retired accountant, has been a dedicated spinner fisherman and Trout Unlimited member since 1979 and has logged nearly 27,000 hours casting spinners. During the last 43 years he has learned and perfected many of the little things that it takes to be successful and he will be sharing them with you. His proven technique has helped him catch and release over 327,000 trout in streams open to free public angling, including an average of over 10,000 trout per year for the last twenty-eight years. While many anglers would consider catching a dozen trout in a day a stellar outing, Frank has averaged over twelve trout per hour during the last thirty-four years.

In addition to his one-hour slide presentation, which will feature new photographs, Frank will give a brief casting demonstration followed by a question and answer period. A handout, "SPIN FISHING FOR WILD TROUT -- Tackle, Tips & Technique" lists the critical points of his program and will be given to everyone. Also, for those interested, a handout showing in detail the parts necessary for constructing homemade spinners.

For anglers who already use spinners, you will not want to miss this chance to take your spin fishing to the next higher level. For bait and fly anglers, Frank guarantees his tips will help you bring more trout, both stocked and wild, to hand. Even people who don't fish have enjoyed Frank's presentation. So why not join us for an enjoyable evening of trout talk and camaraderie. You'll be glad you came.

Dear Members and Friends,

It's my pleasure to thank all the great volunteers in our chapter who, for the third time in the last several years, helped Brodhead TU receive recognition from the PA Council of Trout Unlimited as the Edward Urbas Award for Best Chapter in the Commonwealth. The chapter received the recognition previously in 2015 and 2017. We also had the greatest increase in the number of members in our chapter compared to the other 48 chapters. When you're doing great work, people notice.

Since 2015, our volunteers have given over 1600 hours of their time each year, except for 2020 that was impacted by COVID and we only had a little over 900 hours. Most years our volunteers have spent than

2000 hours helping to educate the community on, advocate for and improve our coldwater resources. In my first column as president of the Brodhead Chapter I would be remiss if I did not recognize the service of Eric Baird, who served as in the position for the last four years. Eric led our organization through the turbulent last four years, most of it dominated with the COVID-19 disruption to all of lives and the long-range plans we had for the chapter. Through it all, he kept us motivated and kept us moving towards the goals the organization set for itself, through Plan A, B, C, and sometime D as the virus forced us to modify our plans.

Even with the disruption we managed to implement several new education initiatives and create a long-range plan for our stream habitat restoration work. We also planned for, and raised the funds, to start phase I of our two-phase project on the McMichaels Creek at the Pocono Heritage Land Trust (PHLT) Pomeroy McMichaels Creek Nature Preserve along Hickory Valley Road near Stroudsburg that will be implemented next month.

While we are in a better place today, we are still dealing with the presence of COVID-19. I was elected president in absentia as I had tested positive for the virus after lunch on the day of our September meeting. Many of our members are still uneasy about coming to meetings and events as is understandable.

I would also like to thank Todd Burns, who most recently served the chapter as Secretary for four years, but was also the immediate past president of Brodhead TU, having served as president for an equalamount of time. The first board meeting I attended in August 2014 was led by Todd who was filling in for the president, who he succeeded the following month. Todd's presence on the board will continue, though he has stepped down from his decade+ plus long service on the executive committee. He led, and continues to lead, the fundraising committee that has been so instrumental to the success of the fundraising effort to support our stream habitat improvement project at the Pomeroy Preserve. Work will begin on that project soon, so keep an eye on your email for volunteer opportunities.

Finally, thank you again for all you do to help the chapter succeed.


Brodhead Chapter activities over the past year included efforts in education,

## NEW Redesignation of the Saucon and Monocacy Creek

The Pennsylvania Fish and Boat Commission has proposed a number of management changes for consideration at the October 24/25, 2022 meeting. The Commission will consider removing segments of Saucon Creek (Section 5) and Monocacy Creek (Section 7) in Northampton County and Codorus Creek (Section 4) in York County currently managed under the "trophy trout artificial lures only" regulations and adding them to the list of waters managed as "artificial lures only trout slot limit". Trophy trout artificial lures only regulations require a minimum size of 18 inches for harvest (when allowable with season restrictions), removing many of the largest fish from the population. The change to a slot limit regulation allows for protection of the largest size fish while allowing for harvest of intermediate size fish (between 7 and 12 inches), when allowable with season restrictions. Harvesting of fish within the slot limit releases resources to be utilized by larger fish. In addition, the Commission will consider adding Penns Creek Section 3 to its list of waters managed under the "All-tackle trout slot limit" program (allowing the harvest of fish between 7 and 12 inches when allowable with season restrictions). ## Camp Trexler

The Minsi Trails Council of the Boy Scouts of America is engaged in discussions to sell their 900+ acre Camp Trexler near Jonas, PA. This beautiful wooded area produces the headwaters of Middle Creek, a wild trout stream in which Brodhead TU will soon undertake a riparian buffer project in Polk Township. If the camp is sold for development, the headwaters of Middle Creek will be susceptible to significant degradation and not available for public use. One local group looking to purchase the property and protect it from development and provide for public access is the Pocono Heritage Land Trust. If you would like to see this land, and the Middle Creek, preserved for future generations, you can contact <u>rich-</u> <u>ardd.christ@scouting.org</u> and let the Council know the importance of preserving this land.

## **BTU Position Statement on Distribution Centers/Warehouse Construction**

Currently, preliminary plans or discussions are being carried out concerning the construction of massive distribution centers throughout the greater Pocono region. Projects are being considered and are in various stages of planning, review, comment and hearings. Several of these are in the Pocono Creek corridor in Pocono Township and also in Coolbaugh Township along Tobyhanna Creek.

Brodhead Trout Unlimited understands warehouse development will occur, and it believes that such development must be done in areas that do not impact the absorption, retention, filtration and free movement of rain water and other precipitation near cold-water resources. It should not reduce the size or quality of wetlands, provide damaging thermal and/or saline stress due to runoff, or cause increased siltation in our streams. The cold, clean trout waters for which the Poconos is known should not be degraded and BTU is willing to work with residents and local governments to achieve this goal.

# **October Fishing Outlook**

Cooler temperatures are upon us, the leaves are turning and the trout are feeding up and getting ready to spawn. It's a good time of year!

Hopefully stream flows will be above the summer lows as we head into an important season in the life of our trout. Wild browns and native brook trout are beginning to stock up on calories and many are getting ready to spawn. You will still find terrestrials such as ants, hoppers, and inchworms around so don't be shy about



trying those imitations. We also can get some late season Isonychia (Slate Drake) and Blue-winged Olives on those dreary, drizzly October days. Of course, don't forget the orange-bodied October Caddis as either a terminal fly or as the dry above a dropper. And who hasn't enjoyed the jarring strike of a fore-arm length brown trout smashing a streamer?



As we get into the latter days of the month, please be on the lookout for trout redds (see image at left). These oval or ovoid clearings are usually found in the shallow tail-outs of pools or runs so stay clear if you are wading. Every year and stream is a bit different as to when the fish build them so be careful over the next few months. We've even observed redd-building activity in December in some headwater streams.

So enjoy the colors of the leaves and our trout, be careful, and tight lines.


