John Maclean Presents: Maclean Country

On Wednesday, April 12, Brodhead TU will host a live, virtual video presentation by author John Maclean. The program, Maclean Country, is a PowerPoint program and commentary about the Maclean family legacy in Montana and elsewhere. Illustrated with contemporary and family photographs, the presentation explores the background of "Home Waters" and "A River Runs Through It."

John N. Maclean is an award-winning author and journalist, and also a Trout Unlimited Life Member. He spent thirty years at the Chicago Tribune, most of that time as a Washington correspondent. After leaving the Tribune, Maclean wrote a series of non-fiction books about wildland fire, beginning with *Fire on the Mountain*, that are considered a staple of fire literature. His memoir, *Home Waters: A Chronicle of Family and a River*, has been hailed as lyrical tribute to his home state of Montana and a worthy follow to his father's novella, *A River Runs Through It*. In an upcoming work, Maclean wrote the foreword to the centennial edition of Ernest Hemingway's "Big Two-Hearted River," scheduled for publication by Mariner Classics on May 9.

Salt, Conductivity and Our Pocono Streams: Part I

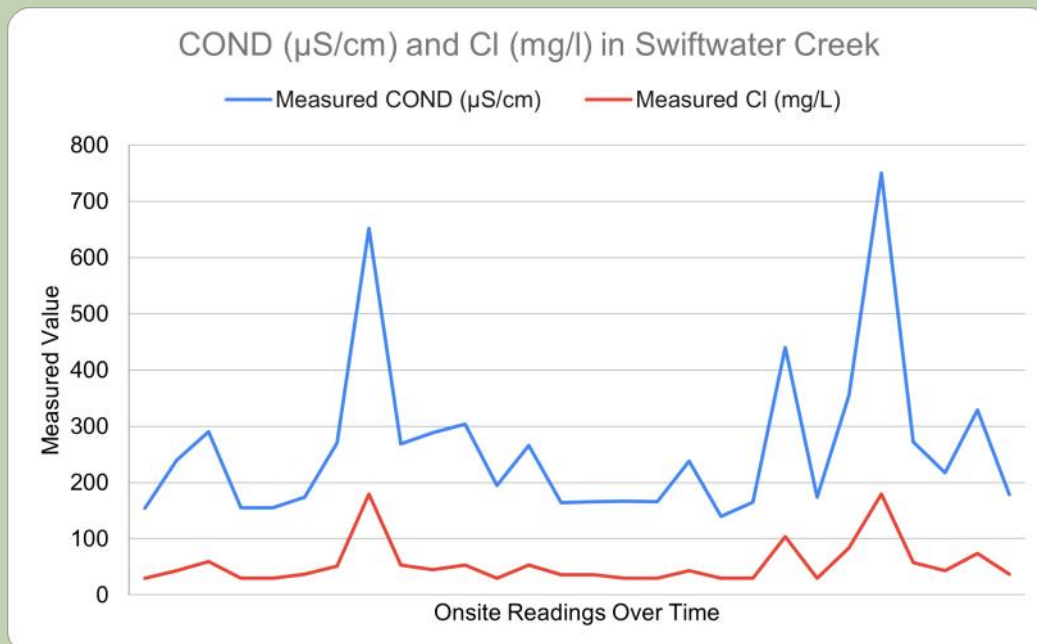
A growing focus of scientific study centers upon the effects of salts introduced into freshwater systems. These salts, generally used to de-ice roadways and parking lots, dissolve in water and are carried into nearby waterways. Such introductions increase the salinity and the electrical conductivities of the receiving waters above base levels. The effects of these changes are the subject of scrutiny: How does this salinization affect the plant and animal life in the streams? Whereas the Poconos has an abundance of free flowing streams, many of them supporting wild and native trout populations, what effects might increased salinity have on an important local sporting industry?

Chemically speaking, the salts we're focused on are inorganic salts. These consist of metal ions bonded to non-metal ions. And while there are a myriad of combinations and types, the most common salts we see are sodium chloride (NaCl) and calcium chloride (CaCl₂). These salts are found in commercially available ice melt products and both are naturally occurring compounds.

As a starting point, it is important to identify if there are streams in the area that are affected. If applications of salts to roads and parking lots run off into nearby waterways, one would expect to see:

1. An increase of Cl⁻ ions and a resulting increase in electrical conductivity in the water. (The more ions dissolved in water, the greater the ability to conduct an electrical current.)
2. Because salt applications occur in the winter months, we'd expect to see such increases between December and March.

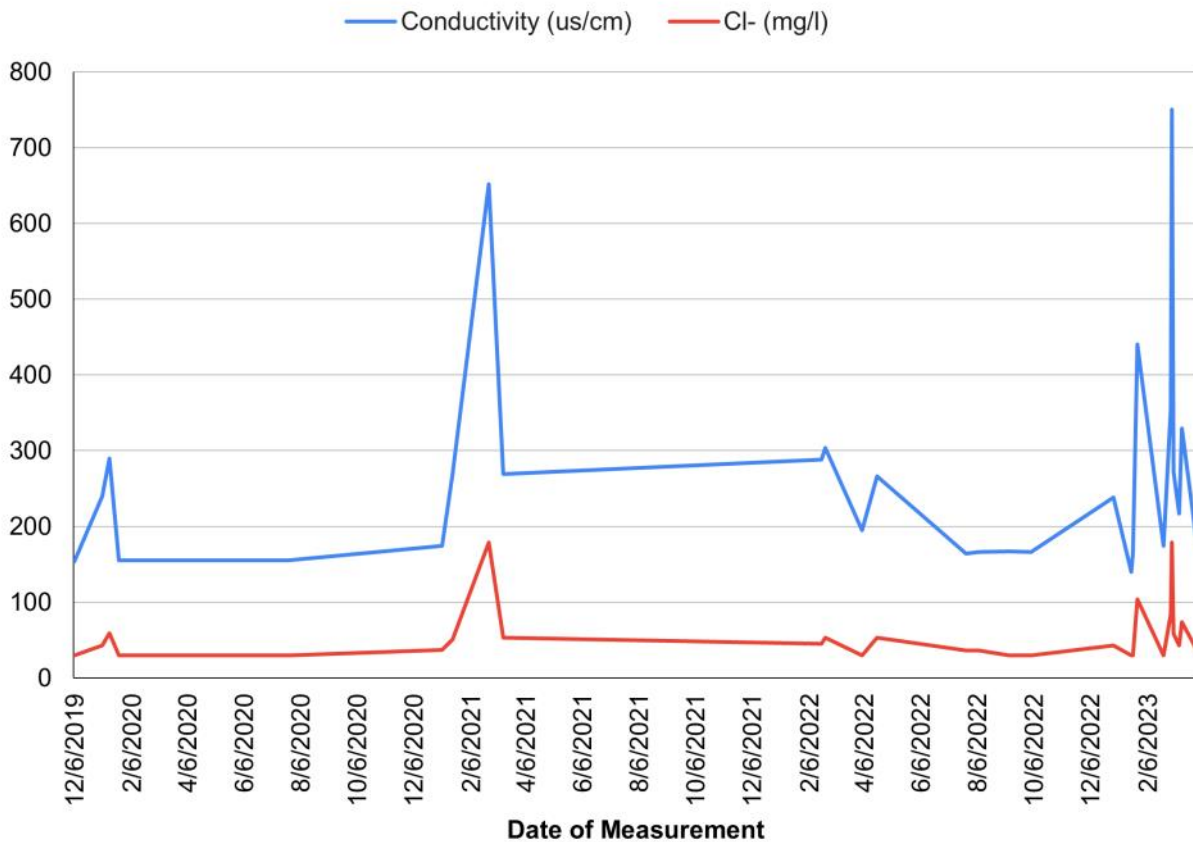
Todd Burns, a BTU Board Member and a Brodhead Watershed Association volunteer, has been measuring Cl⁻ and conductivity on Swiftwater Creek between Pocono Manor and Rte. 611, above its confluence with Indian Run. Swiftwater Creek is an exceptional value (EV) stream with a population of wild brown trout and native brook trout. A plot over time of Cl⁻ concentrations and electrical conductivity from this site produced this graph:



The data indicate a correlation between measured Cl⁻ concentration and electrical conductivity with periods of relative stability with large fluctuations or spikes. Let's look at when those spikes occurred.

Salt, Conductivity and Our Pocono Streams: Part I (cont'd)

An examination of the above plot shows that the large peaks for Cl^- and conductivity values occurred during the winter months. Natural, baseline levels for Cl^- and conductivity were observed in the summer months. These data indicate that something is happening in the winter months that is introducing a load of Cl^- into the water. This is a starting point.

For this particular station, additional study and sampling would be needed to locate sources of Cl^- input. This would entail testing at additional sites upstream of the study site. Due to accessibility issues, this may not be possible. Because the headwaters of Swiftwater Creek form on the west and east sides of Interstate 380, and the stream passes near a resort, the village of Pocono Manor, and SR 314, there are numerous potential areas from which Cl^- may enter.

Swiftwater Creek is just one stream of many in the Poconos. It's waters are affected by seasonal Cl^- increases and it is likely that other streams in our area, being near roadways and development, are likewise affected. In the next part of this series (next month), we'll look at some research that examines what effects Cl^- and conductivity have on macro-invertebrates and other freshwater biota.

As this is a virtual presentation, we will gather at the Kettle Creek Environmental Education Center to participate.
2. **Invasive plant removal** along the Larsen Tract in Cherry Valley at 9 AM on April 22nd (**Note change in date.**) Provides participants an opportunity to reverse decades of growth by invasive species along the banks of Cherry Creek. The chapter’s goal is to eliminate the undesirable invaders and prepare the area for a resurgence of native species. This is a long-term project but, bit by bit, we will succeed. Bring sturdy work gloves.
3. **“Fly Fishing: The Next Step”** provides participants in our Introduction to Fly Fishing Workshop the opportunity to hit the water on May 2nd for some real-world experience. Zacharias Pond is easy to fish and often provides some good action for our beginning fly fishers. A good place to get started.
4. **Veterans’ Fishing Day at VALOR** is scheduled for Saturday, May 6 at 9 AM. It will be held at the VALOR Pavilion at 65 Meckes Lane, White Haven PA. Join us in helping volunteers from VALOR (Veteran Assisted Living, Outreach and Recovery) in assisting veterans in a fishing experience along Black Creek. 7. June 10th brings us two events. In the morning (9 AM), we’ll be running our **Fly Fisherman’s Flea Market** at the Brodhead Creek Heritage Center. We offer used rods and reels along with fly tying materials, other gear, and books at very reduced prices. If you or someone you know is getting started, this is a great opportunity to pick up needed goods without breaking the bank. In the afternoon (3 PM), we’ll be holding our **annual picnic** on the patio of BCHC. Bring a side dish or dessert and come join the fun.

News Notes, Advocacy Opportunities, and Items of Interest

BTU Position Statement on Distribution Centers/Warehouse Construction

Discussions are being carried out concerning the construction of distribution centers throughout the Pocono region. Proposed projects are in various stages of planning, review, comment and hearings in Coolbaugh Township, Tunkhannock Township and Pocono Township. Potentially affected streams and their associated wetlands and tributaries are Mud Pond Run, Pocono Creek and Tobyhanna Creek.

BTU understands warehouse development will occur, and it believes that such development must be done in areas that do not impact the absorption, retention, filtration and free movement of rain water and other precipitation near cold-water resources. It should not reduce the size or quality of wetlands, provide damaging thermal and/or saline stress due to runoff, or cause increased siltation in our streams. The cold, clean trout waters for which the Poconos is known should not be degraded and BTU is willing to work with residents and local governments to achieve this goal.

April Fishing Outlook



April brings the start of the regular season for trout fishing and that means all stocked trout waters, Class A trout waters, and Wild Trout waters are open for fishing. You'll have quite a few options!

The relatively warm, dry late winter and early spring has had an effect on our Pocono streams. What little moisture from the winter has drained away (or evaporated by the winds) and flows are low. Long-term weather forecasts call for warm air temperatures with very little precipitation for at least the next two weeks. Water temperatures, even with cold nights, are moving upward and the mid-April hatches have been here for at least a week. Quill Gordons, Hendricksons, brown stoneflies and early season caddis are out and about as are the ubiquitous baetis. These hatches have been popping up in the afternoon hours after the water warms a bit. Stones first, then some caddis and finally the mayflies.



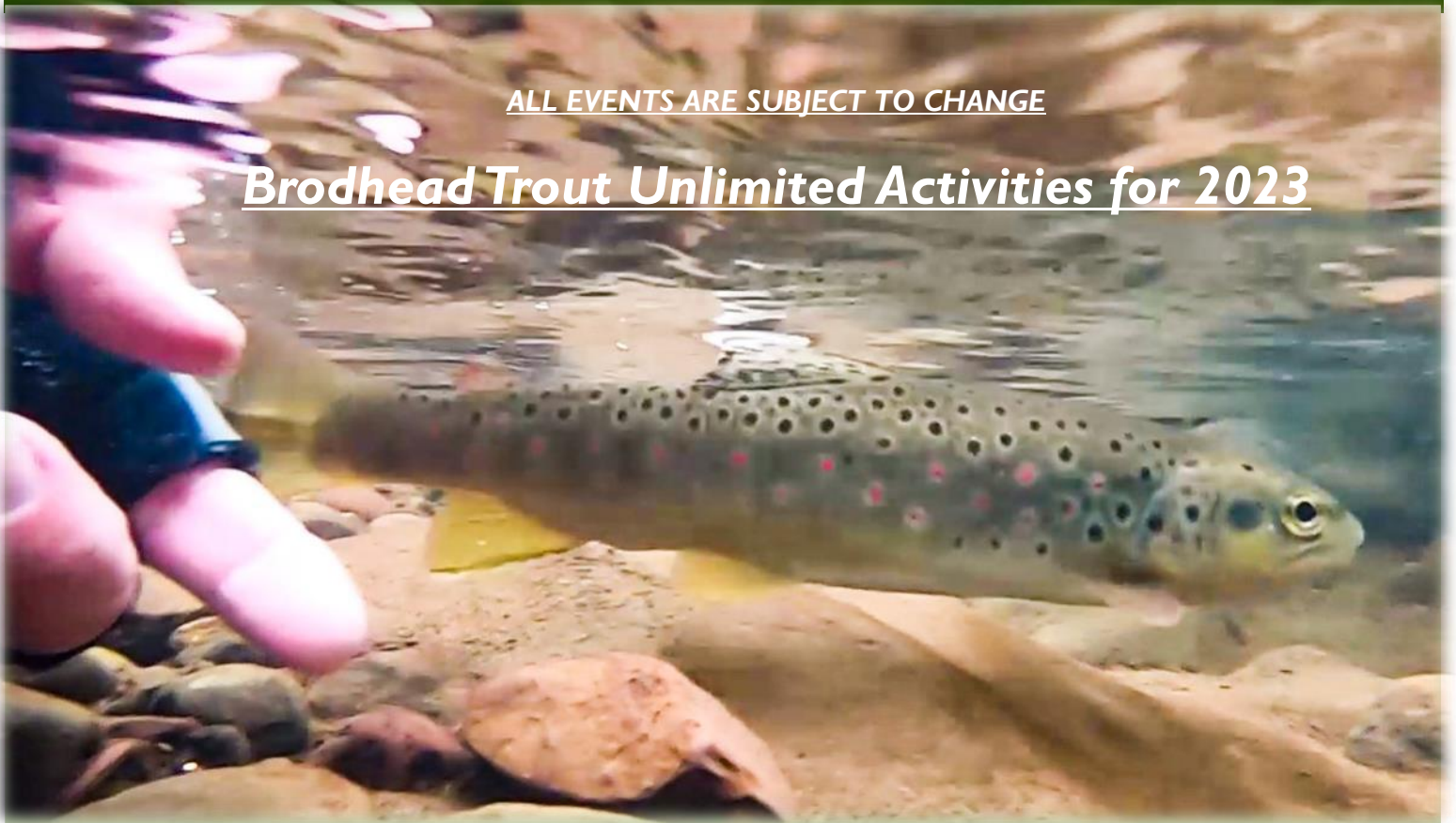
A size #16 olive-brown caddis skittered or dead-drifted on the surface can be a good producer under these conditions. Of course, don't forget some pupae and emerger patterns. Short-stripping an emerging caddis pattern can trigger some vicious strikes.

If you're fortunate enough to be present for a decent Quill Gordon or Hendrickson hatch, the fish will be focused on some form of the insect. It's not unusual to see duns dancing on the surface with no takers. If that's the case, try a nymph or emerger pattern. Also, you'll often see crippled emergers and adults floating by. Trout feed on these as they can't fly away! Be ready to change a few patterns until you find the right one.

Get out on the streams and see what's happening. May your lines be tight and wriggling!
