

Invasive Plant Removal Along Cherry Creek: April 12 at 1 PM. Work Area: Larsen Lane Meet at: Headquarters Building



The chapter's next volunteer event will be an invasive plant removal workday on Larsen Lane within the Cherry Valley National Wildlife Refuge. The tract of land borders Cherry Creek and the chapter has been working to remove invasive plants and replace them with native species.

Surrounding woodlands in this area were predominantly ash trees that succumbed to the effects of the emerald ash borer. The removal of the leafy canopy enabled unwanted plants to thrive. In addition to removing the invasives, the chapter has planted the area with native species

of trees and shrubs in both the wet, bottom-lands and the drier slopes with the goal of providing new, shading canopy for the creek and forest floor.

If you plan to join us, waterproof shoes/boots and heavy gloves are strongly encouraged.

Brodhead Trout Unlimited members and friends will be picking up trash in and near Pocono Creek and Bisbing Run in Tannersville, PA. Light to medium weight gloves are suggested as the materials to be picked up are quite varied.



# News Notes, Advocacy Opportunities, and Items of Interest



### **BTU Position Statement on Distribution Centers/Warehouse Construction**

Discussions are being carried out concerning the construction of distribution centers throughout the Pocono region. Proposed projects are in various stages of planning, review, comment and hearings in Coolbaugh Township, Tunkhannock Township and Pocono Township. Potentially affected streams and their associated wetlands and tributaries are Mud Pond Run, Pocono Creek and Tobyhanna Creek.

BTU understands warehouse development will occur, and it believes that such development must be done in areas that do not impact the absorption, retention, filtration and free movement of rain water and other precipitation near cold-water resources. It should not reduce the size or quality of wetlands, provide damaging thermal and/or saline stress due to runoff, or cause increased siltation in our streams. The cold, clean trout waters for which the Poconos is known should not be degraded and BTU is willing to work with residents and local governments to achieve this goal.

### **New:** Special Regulation Designation; Removal of Lower Woods Pond; Big Bass Program

Comments may be submitted by mail to: Executive Director, Fish and Boat Commission, P.O. Box 67000, Harrisburg, PA 17106-7000, within 30 days after publication of the notice in the *Pennsylvania Bulletin*. Electronic submission can be made to RA-pfbcregulations@pa.gov. As before, just <u>be sure to identify which</u> proposal you are commenting upon.

### Method to Comment On Proposed Regulatory Changes

Until the end of 2023, PFBC accepted comments on upcoming regulatory proposals through email and a web-based application, in addition to regular mail. Currently, comments will need to be made via mail or the email RA-pfbcregulations@pa.gov . The proposed regulations are still posted on line for your review **BUT** they are on the **Pennsylvania Bulletin** site. To review the proposed changes, you will need to navigate by following the steps below:

- 1. Click on this **Pennsylvania Bulletin link**.
- 2. Under "BULLETIN", select the most recent volume.
- 3. Select the most recent issue(s).
- 4. Select "Pennsylvania Fish and Boat Commission" from the menu. You will see any pending proposals as a hyperlink.
- 5. Select the proposal and it should open so you can read it.

### Pennsylvania's Trout Season is officially open!

It's April, the streams and ponds are warming and the prime trout fishing is just getting started. We hope you can get out and enjoy our Pocono waters this month. It's a great time to be out and about on your favorite stream.

Trout love to munch on the juvenile and adult forms of our Pocono macro-invertebrates. Now that the days are longer and the water is warming, let's take a look at what is happening and what will be occurring shortly.

We're been seeing blue-winged olives hatching, mostly on those cool, overcast mornings. Size #18 is a good place to start, whether it be patterns that imitate nymphs, emergers, cripples or adult duns. There are also some early stoneflies out an about. A brownish-gray imitation in a size #14 should work there. Word is out that Quill Gordons are emerging so get your #12 imitations ready to do some work. Don't forget some nymph and emerger patterns, either. Depending on where you fish, you may find some Blue Quills flying about so a #16 pattern is a good place to start. Shortly, we'll see Hendricksons (Red Quills and Pink Ladies) and tan and green caddis. Stock the box with nymphs through adults.

If we get some rains and the waters elevate, don't be afraid to put on some larger imitations such as a Pat's Rubber Legs and black Woolly Buggers.
